**1.** A clinging state arises dependent on a clinging state by root condition -dependent on clinging to views, clinging to sensual pleasures arises; dependent on clinging to sensual pleasures, clinging to views arises; dependent on clinging to moral rules and austerities, clinging to sensual pleasures arises; dependent on clinging to sensual pleasures, clinging to moral rules and austerities arises; dependent on clinging to the doctrine of self, clinging to sensual pleasures arises; dependent on clinging to sensual pleasures, clinging to the doctrine of self arises. By way of root five, by way of object two... etc. by way of non-disappearance five.

(This dyad is similar to the mundane dyad in the Minor Intermediate Dyads, the difference.)

*The dissociated from clinging-subject to clinging dyad is finished.*

*The clinging group is finished.*

*The third section is finished.*
