##### 1-4. Positive Condition and so on

**1.** A mental state with condition arises dependent on a mental state with condition by root condition - dependent on one aggregate with condition, three aggregates and consciousness-originated materiality arise... etc. two aggregates... etc. at the moment of conception... etc. dependent on aggregates, the sense-base arises; dependent on the sense-base, aggregates arise; dependent on one primary element... etc. dependent on primary elements, consciousness-originated materiality, kamma-born materiality, and derivative materiality arise.

A mental state with condition arises dependent on a mental state with condition by object condition... etc. By non-disappearance condition.

**2.** By way of root one, by way of object one... etc. by way of non-disappearance one.

**8.** A mental state with condition is a condition for a mental state with condition by way of root condition - roots with condition are a condition for associated aggregates and for consciousness-originated materiality by way of root condition; at the moment of conception... etc.

##### Object condition

**9.** A mental state with condition is a condition for a mental state with condition by way of object condition - having given a gift, having taken upon oneself morality, having performed the Observance practice, one reviews that; what was well practised before... etc. having emerged from meditative absorption... etc. noble ones, having emerged from the path, review the path, review fruition; the abandoned defilements... etc. the suppressed defilements... etc. they know the defilements previously indulged in, the eye... etc. the sense-base... aggregates with condition as impermanent... etc. displeasure arises; One sees materiality with the divine eye, hears sound with the divine ear element. With the knowledge of others' mental states one knows the consciousness of one possessing consciousness with condition, the plane of infinite space is a condition for the plane of infinite consciousness... etc. the plane of nothingness is a condition for the plane of neither-perception-nor-non-perception, etc. the visible form sense base for eye-consciousness... etc. the touch sense base for body-consciousness... etc. Aggregates with condition are a condition by way of object condition for the knowledge of various kinds of supernormal power,

for the knowledge of others' mental states, for the knowledge of recollecting past lives, for the knowledge of rebirth according to beings' actions, for the knowledge of future events, for adverting. (1)

A mental state without condition is a condition for a mental state with condition by way of object condition - noble ones review Nibbāna; Nibbāna is a condition by way of object condition for change-of-lineage, for cleansing, for the path, for fruition, for adverting. (1)

### Predominance condition

Connascent predominance - predominance with condition is a condition for associated aggregates and for consciousness-originated materiality by way of predominance condition. (1)

A mental state without condition is a condition for a mental state with condition by way of predominance condition. Object predominance - noble ones, having given weight to Nibbāna, review; Nibbāna is a condition by way of predominance condition for change-of-lineage, for cleansing, for the path, for fruition. (1)

Nibbāna is a condition by way of predominance condition for change-of-lineage, for cleansing, for the path, for fruition; the eye... etc. Having given weight to the sense-base, non-manifest aggregates, one enjoys them, delights in them; having given weight to that, lust arises, wrong view arises. (1)

**38.** A non-manifest phenomenon is a condition for a non-manifest phenomenon by way of contiguity condition... by way of conascence condition... three... by way of mutuality condition... one... by way of support condition... three.

### Decisive support condition

**39.** A manifest phenomenon is a condition for a non-manifest phenomenon by way of decisive support condition - object decisive support, natural decisive support, etc. Natural decisive support - aspiring for accomplishment in beauty one gives a gift, etc. morality... etc. performs the Observance practice, accomplishment in beauty is a condition for faith, etc. for longing... for bodily pleasure, for bodily pain, for the path, for fruition attainment by way of decisive support condition. (1)

A non-manifest phenomenon is a condition for a non-manifest phenomenon by way of decisive support condition - object decisive support, proximity decisive support, natural decisive support, etc. Natural decisive support - in dependence on faith one gives a gift, etc. produces attainment, mutters conceit, takes wrong view; morality... etc. in dependence on lodging one gives a gift, etc. breaks the Community; faith, etc. lodging for faith, etc. for fruition attainment by way of decisive support condition.(1)

### Prenascence condition

**40.** A manifest phenomenon is a condition for a non-manifest phenomenon by way of prenascence condition - manifest matter as impermanent... etc. displeasure arises; one sees materiality with the divine eye; the visible form sense base is a condition for eye-consciousness by way of prenascence condition. (1)

A non-manifest phenomenon is a condition for a non-manifest phenomenon by way of prenascence condition - object prenascence, sense-organ prenascence. Object prenascence - the eye... etc. the sense-base as impermanent... etc. displeasure arises; one hears sound with the divine ear element; the sound sense base for ear-

consciousness... etc. The touch sense base is a condition for body-consciousness by way of prenascent condition. Sense-organ prenascent - the eye sense base for eye-consciousness... etc. the body sense base for body-consciousness... etc. the sense-base is a condition for non-manifest aggregates by way of prenascent condition. (1)

A manifest and a non-manifest phenomenon are conditions for a non-manifest phenomenon by way of prenascent condition - object prenascent, sense-organ prenascent. The visible form sense base and the sense-base are a condition for non-manifest aggregates by way of prenascent condition; the visible form sense base and the eye sense base are a condition for eye-consciousness by way of prenascent condition. (1)

### Postnascent condition

**41.** A non-manifest phenomenon is a condition for a non-manifest phenomenon by way of postnascent condition - postnascent non-manifest aggregates are a condition for this prenascent non-manifest body by way of postnascent condition. (1)

A non-manifest phenomenon is a condition for a manifest phenomenon by way of postnascent condition - postnascent non-manifest aggregates are a condition for this prenascent manifest body by way of postnascent condition. (2)

A non-manifest phenomenon is a condition for a manifest and a non-manifest phenomenon by way of postnascent condition - postnascent non-manifest aggregates are a condition for this prenascent manifest and non-manifest body by way of postnascent condition. (3)

### Repetition condition

**42.** A non-manifest phenomenon is a condition for a non-manifest phenomenon by way of repetition condition - the former and former non-manifest aggregates for the latter and latter non-manifest aggregates... etc. Conformity for change-of-lineage, etc. conformity for cleansing, etc. change-of-lineage for the path, etc. cleansing is a condition by way of repetition condition for the path. (1)

### Kamma condition

**43.** A non-manifest phenomenon is a condition for a non-manifest phenomenon by way of kamma condition - conascent, asynchronous.
