600-611. Natthi ettha mataṃ maraṇaṃ vināsoti amataṃ, nibbānanti āha - “maraṇavirahitaṃ nibbānaṃ paribhuñjantī”ti. Amatassa vā nibbānassa adhigamahetutāya amatasadisatappakasukhapatitatāya ca kāyagatāsati “amata”nti vuttā. Paribhuñjantīti jhānasamāpajjanena vaḷaṇṇanti. Viraddhanti anadhigamena virajjhitaṃ. Tenāha - “virādhitaṃ nādhigata”nti. Āraddhanti sādhitāṃ nipphāditāṃ. Tañca paripuṇṇaṃ nāma hotīti āha - “āraddhanti paripuṇṇa”nti. Pamādiṃsūti kālabyattayenedaṃ vuttanti āha - “pamajjantī”ti.
