1-7. Section on the Dependent etc.

The Tetrad of Conditions

Root Condition

- 1.** A non-mental hindrance wholesome mental state arises dependent on a non-mental hindrance wholesome mental state by root condition (in brief).
- 2.** By way of root one, by way of object one... etc.by way of non-disappearance one (abbreviated).

(In the section on conascence also... etc.in the section on questions also everywhere one).

- 3.** A mental hindrance unwholesome mental state arises dependent on a mental hindrance unwholesome mental state by root condition. A non-mental hindrance unwholesome mental state arises dependent on a mental hindrance unwholesome mental state by root condition. Mental hindrance unwholesome and non-mental hindrance unwholesome mental states arise dependent on a mental hindrance unwholesome mental state by root condition. (3) (Abbreviated.)

- 4.** By way of root nine, by way of object nine... etc.by way of non-disappearance nine (abbreviated).

Negative.

Non-root Condition

- 5.** A mental hindrance unwholesome mental state arises dependent on a mental hindrance unwholesome mental state by non-root condition - dependent on the mental hindrance of sceptical doubt and the mental hindrance of restlessness, the mental hindrance of ignorance arises. (1)

A mental hindrance unwholesome mental state arises dependent on a non-mental hindrance unwholesome mental state by non-root condition - dependent on aggregates accompanied by sceptical doubt and accompanied by restlessness, the mental hindrance of ignorance arises. (1)

A mental hindrance unwholesome mental state arises dependent on a mental hindrance and non-mental hindrance unwholesome mental state by non-root condition - dependent on the mental hindrance of sceptical doubt and the mental hindrance of restlessness and associated aggregates, the mental hindrance of ignorance arises. (1) (Abbreviated.)

- 6.** By way of non-root three, by way of non-predominance nine, by way of non-prenascence nine... etc. by way of non-kamma three... etc.by way of the not dissociated nine (abbreviated).

(In the section on conascence also... in the associated section also everywhere nine.)

7. A mental hindrance unwholesome mental state is a condition for a mental hindrance unwholesome mental state by way of root condition (in brief).

8. By way of root three, by way of object nine, by way of predominance nine... etc. by way of repetition nine, by way of action, by way of nutriment, by way of faculty, by way of meditative absorption, by way of path three, by way of association nine... etc. by way of non-disappearance nine (abbreviated).

By way of non-root nine, by way of non-object nine (in brief).

By root condition: by way of non-object three (in brief).

By non-root condition: by way of object nine (in brief).

(Just as the positive, negative, positive-negative and negative-positive of the section on questions in the triad of wholesome was counted, so it should be counted.)

12. By way of root two, by way of object two... etc. by way of non-disappearance two (abbreviated).

19. An unwholesome mental state associated with mental hindrances arises dependent on an unwholesome mental state associated with mental hindrances by root condition (in brief).

An unwholesome mental state that is subject to mental hindrances and not mental hindrance arises dependent on an unwholesome mental state that is subject to mental hindrances and not mental hindrance by root condition... three.

A mental hindrance and subject to mental hindrances unwholesome mental state arises dependent on an unwholesome mental state that is both mental hindrance and subject to mental hindrances and an unwholesome mental state that is subject to mental hindrances and not mental hindrance by root condition... three (abbreviated).

26. By way of root nine, by way of object nine... etc.by way of non-disappearance nine (abbreviated).

49-1. Dissociated from Mental Hindrances-Subject to Mental Hindrances Dyad-Wholesome Triplet

The Tetrad of Conditions

Root Condition

31. A wholesome mental state dissociated from mental hindrances and subject to mental hindrances arises dependent on a wholesome mental state dissociated from mental hindrances and subject to mental hindrances by root condition. (1)

A wholesome mental state dissociated from mental hindrances and not subject to mental hindrances arises dependent on a wholesome mental state dissociated from mental hindrances and not subject to mental hindrances by root condition. (1)
(Abbreviated.)

32. By way of root two, by way of object two... etc.by way of non-disappearance two (abbreviated).

33. A dissociated from mental hindrances and subject to mental hindrances indeterminate mental state arises dependent on a dissociated from mental hindrances and subject to mental hindrances indeterminate mental state by root condition. (1)

A dissociated from mental hindrances and not subject to mental hindrances indeterminate mental state arises dependent on a dissociated from mental hindrances and not subject to mental hindrances indeterminate mental state by root condition... three.

A dissociated from mental hindrances and subject to mental hindrances indeterminate mental state arises dependent on a dissociated from mental hindrances and subject to mental hindrances indeterminate and dissociated from mental hindrances and not subject to mental hindrances indeterminate mental state by root condition. (1) (Abbreviated.)

34. By way of root five, by way of object two... etc.by way of result five (in brief).

(In the section on consciousness also... etc.in the section on questions also it should be expanded everywhere.)

The mental hindrance group with the triad of wholesome is finished.
