A mental state that is defiled and subject to defilement arises dependent on a mental state that is defiled and subject to defilement by root condition - dependent on one aggregate that is defiled and subject to defilement, three aggregates arise... etc. dependent on two aggregates, two aggregates arise. A mental state that is undefiled but subject to defilement arises dependent on a mental state that is defiled and subject to defilement by root condition - dependent on aggregates that are defiled and subject to defilement, consciousness-originated materiality arises. (2)

Mental states that are defiled and subject to defilement and mental states that are undefiled but subject to defilement arise dependent on a mental state that is defiled and subject to defilement by root condition - dependent on one aggregate that is defiled and subject to defilement, three aggregates and consciousness-originated materiality arise... etc. dependent on two aggregates, two aggregates and consciousness-originated materiality arise.
