Adhikaraṇabhedaṇṇanā

340. Yasmā adhikaraṇaṃ ukkoṭento samathappattameva ukkoṭeti, tasmā “vivādādhikaraṇaṃ ukkoṭento kati samathe ukkoṭetī”tiādi vuttaṃ.

341. Pāḷimuttakavinicchayenevāti vinayalakkhaṇaṃ vinā kevalaṃ dhammadesanāmatavasenevāti attho. Yenāpi vinicchayenāti pāḷimuttakavinicchayameva sandhāya vuttaṃ. Khandhakato ca parivārato ca suttenāti khandhakaparivārato ānītasuttēna. Nijjhāpentīti paññāpentī.

342. Kiccaṃ nissāya uppajjanakakiccānanti pubbe kataukkhepanīyādikiccaṃ nissāya uppajjanakakiccānaṃ. Kīdisānaṃ? Yāvatatīyasamanubhāsanādīnaṃ.

343. Taṃ hīti taṃ vivādādhikaraṇaṃ.

344. Adhikaraṇesu yena adhikaraṇena sammanti, taṃ dassetuṃ vuttanti yadā adhikaraṇehi sammanti, tadā kiccādhikaraṇeneva sammanti, na aññehi adhikaraṇehīti dassanattamaṃ vuttanti adhippāyo.

353. “Sattannaṃ samathānaṃ katame chattiṃsa samuṭṭhānā”ti pucchitvāpi “kammaṣa kiriyā karaṇa”ntiādinā sammukkhāvinayassa samuṭṭhānāni avibhajitvāva sativinayādīnaṃ channaññeva cha samuṭṭhānāni vibhattāni, taṃ kasmāti āha “kiñcāpi sattannaṃ samathāna”ntiādi. Sativinayādīnaṃ viya saṅghasammukhatādīnaṃ kiccayatā nāma natthīti āha “kammasaṅgahābhāvenā”ti.
